

## Employee Benefit Plans – Summary Annual Report

This document contains the Summary Annual Reports covering the BMO Financial Corp. employee benefits plans for the year ending December 31, 2019. The timing, contents, and format of this information complies with government regulations. The information provides a good synopsis of the year's activities.

**This is a summary of the Annual Reports of the following BMO Financial Corp. (EIN# 51-0275712) benefit plans for the period January 1, 2019 through December 31, 2019:**

- Employees' 401(k) Savings Plan of Bank of Montreal/Harris – Plan No. 001
- Employee Benefit Program of Bank of Montreal/Harris (health, dental, vision, prescription drug, long-term disability, life insurance and accident insurance welfare plans) – Plan No. 507
- BMO Harris U.S. Supplemental Unemployment Benefit, U.S. Severance Benefit and U.S. Excess Severance Benefit Plans – Plan No. 511

The annual reports have been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **EMPLOYEES' 401(K) SAVINGS PLAN OF BANK OF MONTREAL/HARRIS:**

#### **Basic Financial Statement**

Benefits under the Plan are provided by a trust fund. Plan expenses were \$183,763,670. These expenses included \$1,768,675 in administrative expenses, \$179,206,297 in benefits paid to participants and beneficiaries, and \$2,788,698 in other expenses. A total of 19,726 persons were participants in or beneficiaries of the Plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of Plan assets, after subtracting liabilities of the Plan, was \$2,333,947,769 as of December 31, 2019, compared to \$1,874,989,817 as of January 1, 2019. During the plan year the Plan experienced an increase in its net assets of \$458,957,952. This increase includes unrealized appreciation and depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The Plan had total income of \$642,721,622. This consists of employer contributions of \$96,397,540; employee contributions of \$107,041,004; rollovers of \$12,641,465; and gains on investments of \$426,641,613.

**EMPLOYEE BENEFIT PROGRAM OF BANK OF MONTREAL/HARRIS:****Insurance Information**

The Plan has contracts with experience-rated insurance plans: Vision Service Plan (VSP), ReliaStar Life Insurance Company, Sun Life Insurance Company, Aetna Life Insurance Company and Chubb Insurance Company of Canada; and also self-insured plan administrators: Blue Cross Blue Shield of Illinois, UMR, Inc., United Healthcare Services Inc., Delta Dental, Express Scripts and The Hartford, to pay all medical, dental, vision, prescription drug, long term disability, life insurance and accident insurance claims incurred under the terms of the Plan. The total premiums paid for the experience-rated contracts for the plan year ending December 31, 20189, was \$21,029,727. The premium costs for the experience-rated contracts are affected by, among other things, the number of and the size of claims.

The value of Plan assets, after subtracting liabilities of the Plan, was \$237,488,700 as of December 31, 2019, compared to \$218,766,886 as of January 1, 2019. During the plan year, the Plan experienced an increase in its net assets of \$18,721,814. This increase includes unrealized appreciation and depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year.

During the plan year, the Plan had total income of \$178,132,948. This consists of employer contributions of \$99,329,801; employee contributions of \$48,143,244; and interest and dividend income of \$7,184,046; and \$23,475,857 in net realized and unrealized appreciation in fair value on investments. The Plan also received a transfer of assets of \$13,752 from the Employees' Retirement Plan of Bank of Montreal/Harris into the Plan's 401(h) account.

Plan expenses were \$159,424,886. These expenses included \$125,204,416 in medical benefits paid to its participants or beneficiaries; \$3,620,983 in long-term disability benefits; \$21,029,727 net to insurance carriers for provision of benefits; and \$9,569,760 in administrative expenses.

**BMO HARRIS U.S. SUPPLEMENTAL UNEMPLOYMENT BENEFIT, U.S. SEVERANCE BENEFIT AND EXCESS SEVERANCE BENEFIT PLANS**

The value of Plan assets, after subtracting liabilities of the Plan, was \$49,444 as of December 31, 2019, compared to \$47,856 as of January 1, 2019. During the plan year, the Plan experienced an increase in its net assets of \$1,588. This increase includes unrealized appreciation and depreciation in the value of the Plan assets; that is, the difference between the value of the Plan' assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the Plan had total income of \$24,883,739 including employer contributions of \$24,878,978 and earnings on investments of \$4,761.

Plan expenses were \$24,882,151. These expenses included \$24,669,968 in benefits paid to participants and beneficiaries and \$212,183 in administrative expenses.
